### Season 2018/19

Welcome to anyone reading our Newsletter for the first time. If you are new to BHR and want to know anything, please just get in touch.

It only seems a few days since this season started and we are well over two thirds of the way through. Ironically, the weather in January was not too bad and the Warring ton League could have played through this year. I guess, as usual we can blame the English weather for being so unpredictable.

### Presentation Day

We have (provisionally) booked De La Salle for our presentation day on **8<sup>th</sup> June 2018** so please try to keep the day free. The format will be similar to last year with short inter-club matches being played before presentation of trophies.

### Fees for 2019/20

At their last meeting the coaches decided to simplify the payment of fees from May onwards.

A significant amount of time each month is taken by our Secretary having to remind parents to pay the fees for their youngsters. To ease this burden the coaches have decided the following:

**“BHR financial year runs from 1<sup>st</sup> May to 30<sup>th</sup> April each year.**

**Fees will be due on the 1<sup>st</sup> of each month payable by Standing Order, if paying monthly. Cash or cheque will not be accepted.**

**Members not paying will be excluded from training or playing until fees paid up to date.**

**Any member not paying on 1<sup>st</sup> of consecutive months will be de-registered until all fees paid up to date.**

**Alternatively, the annual membership fee can be paid directly into the bank as a lump sum but must be paid before the end of July each year.**

**If anyone has difficulty paying the fees, the club is very willing to help. Initial contact should be made to the club Welfare Officer who will act in confidence.”**

On behalf of the coaches I want to emphasise that the last thing we want to do is stop youngsters playing football but we sadly, we will have to stop youngsters playing if fees are not paid on time. We have over 300 members at the moment and I would ask if you are one of the few that we have to remind each month, that you set up a standing order on 1<sup>st</sup> of each month.

My apologies for “labouring” this point but it is important that we streamline our Club’s administration procedures as we continue to grow.

## **Codes of Conduct**

Our codes of conduct can be found on our website ([www.bleakhillrovers.com](http://www.bleakhillrovers.com)) and as part of the season 2019/20 application form, you will be asked to confirm that you have read and will abide by our Codes of Conduct.

We are fully supportive of the FA and League's stance on the conduct of players and parents and we will take appropriate action if anyone contravenes the codes.

## **Photographs/Videos of matches**

As a club we do not encourage parents/coaches to video all or part of matches. Anyone wishing to take a short video of any match must have prior permission of the teams' coach, the opposition's coach and the referee.

We have some players in the club (as do some of our opposition) who do not want their photographs to appear on social media, please respect this as you will probably not be aware who those players are.

## **Wildcats**

As many of you will be aware we have a successful Wildcats (girls) group training every Sunday at 2pm on Bleak Hill School Field. We have been invited by both Bleak Hill School and Eccleston Mere to run "taster" sessions in the next half term.

We will have a girls team running in a League from September and hope to follow that with more teams as next season progresses.
